New Delhi: The Centre on Tuesday asked the National Human Rights Commission (NHRC) to stop citing past cases for retrospective amendments in the Aadhaar Act, which is being seen as an infringement on its powers and so violating Article 21 of the Constitution. A five-member bench of the Supreme Court has struck down Section 57A, which mandated that the State shall ensure that Aadhaar card is stored by all organisations that demand proof of identity and address. The bench had reserved the decision after an impassioned argument between senior counsel Rakesh Dwivedi for the Centre and social activist Prashant Bhushan, who argued that the court should examine the Aadhaar Act's impact on the rights of individuals. The bench had earlier referred to the Aadhaar Act to suggest that the statute was only aimed at preventing corruption. Senior advocate Gopal Subramanium, appearing for the Centre, told the bench that the NHRC has "no independent jurisdiction" in examining whether the Aadhaar Act is unconstitutional. He said there was no need to examine the statute in the context of the Aadhaar Act, because such amendments in the Act which deal with the implementation of the Act are within the purview of the Union Cabinet. The Centre has since made amendments in the Aadhaar Act in 2016, 2017 and 2018, during which time, it has issued reminders to all citizens about the need to link their Aadhaar numbers with bank accounts, mobile phones and PANs, and to give them correct and current addresses. Dwivedi argued that the Centre's "continuous amendments" to the Aadhaar Act are in "vitiating" its original objective. "The Government has given continuous amendments, i.e. from 2016, 2017 and 2018. We may say it has been exercising the 'arbitrary exercise of power' and we have filed a caveat," he argued. Subramanium, however, argued that the Centre's amendments were "entirely necessary" and that there was nothing arbitrary about it. He said the "statutory objects" of the Aadhaar Act were not attained and that amendments were necessary to address the "future challenges and issues" that have cropped up. Section 57A of the Aadhaar Act has been criticised by various individuals and organisations, including the petitioners in the case.
